- **Welcome and Introductions:** PEACE Coordinator, Amy Hawthorne opened the meeting - members signed in.
- March meeting minutes need approved. Corrections include: ~~April Hill~~ to Amy Hill in attendance, and “Student Rep. meeting will take place in May ~~2016~~” to 2017. With these corrections noted, Amy Hill approved March meeting minutes.
- **General Meeting:**
 - Day of Silence – Delaware Hayes High School celebrated DOS on April 21, 2017 had a very successful turn out and held a “break the silence” party at the end of the school day. Buckeye Valley High School will hold their DOS on April 28, 2017 (they had to move their day back due to prom activities). As of now the proclamation hasn’t been approved, Nancy will follow-up.
 - Delaware County YRBS Launch – May 11, 2017. No RSVP is needed to attend; the event is open to the public. The research will be presented by the third party entity that collected and analyzed the data.
- **PEACE Sub-Committees:**
 - **Prevention Awareness Sub-Committee** – Is working on PEACE Student Representatives – Student Rep. Meeting to take place in June 2017.
 - **Infrastructure Sub-Committee now identifies as the PEACE Steering Committee** - will update the PEACE SP and hear recommendations as it’s developed.
 - **Infrastructure Sub-Committee now identifies as the PEACE Steering Committee** – Recommends moving general meetings to every other month instead of the current monthly schedule. Group approves recommendation and it’s decided the PEACE Meetings will occur every other month. To assist in the transition and to clarify, we’ll meet May, June, August, October, December, February, April, etc. Our next meeting will take place on May 17, 2017 at 8:00am.
 - **Infrastructure Sub-Committee now identifies as the PEACE Steering Committee** – The Steering Committee is reevaluating our Mission and Vision Statements to make sure they’re relevant and current. Drafts will be presented to the PEACE Collaborative for approval.

- Nancy Radcliffe - HelpLine’s Sexual Assault Response Network (SARN) is hosting a vision board workshop for anyone who may have experienced sexual assault, abuse, harassment, trauma, or relationship violence. The event was held on April 29th. Walk a Mile event will take place May 5th, during Delaware’s First Friday. HelpLine staff will participate in Advocacy at the Statehouse

with the Ohio Alliance to End Sexual Violence. HelpLine has entered into an MOU with the new Mt. Carmel Hospital in Delaware and will begin to provide rape crisis services there. HelpLine is looking to fill a SARN Contingency Advocate position and a SARN Coordinator for Crawford and Wyandot Counties.
